- 13) Litter owner agrees to prescreen any potential buyers to help set up each offspring for the best life possible with an owner who fully understands what owning a Great Dane entails.
- 14) Litter owner will not to not knowingly sell any offspring to broker, miller, auction, pet store (private and chain) or backyard breeder. Litter owner also agrees to have a written contract in force for each offspring, to guarantee the lifetime protection of the offspring. Repeat Service -

1) We guarantee at least two (2) live puppies to be born in your litter. If after your first breeding the pregnancy does not take, you must take your bitch in to have a full reproductive exam by a licensed reproductive veterinarian. There will not be a second breeding without said exam by a licensed reproductive veterinarian. If cleared by the vet, second breeding will be at no cost to you IF doing live cover. If shipping fresh, you must cover the expense of collection and shipping of semen.

Both Parties Agree –

- 1) The Stud Fee is a payment of Stud service ONLY. Is in NOT to be considered a guarantee of pregnancy of pregnancy or puppies surviving the whelping.
- 2) We agree to furnish each other with needed documentation pursuit the contract. Such as AKC paperwork, Pedigrees, photos, veterinarian information, health certifications, negative Brucellosis test within 10 days prior to breeding.
- 3) All puppies from this litter are to be AKC registered.
- 4) Agree that the Stud dog owner is NOT liable for any diseases or injury to the Bitch resulting from this breeding(s). Stud dog owner has taken all precautions to screen for diseases.
- 5) Bitch owner agrees to allow Stud owner share any photos of said Studs off spring.
- 6) Ohana Great Danes of Michigan must be notified of any refused offspring. Any refused dog produced by our stud dog that the Litter Owner cannot not care for must be given to us free of charge with AKC registration signed over to Ohana Great Danes of Michigan.
- 7) Ohana Great Danes of Michigan must be notified of any breach of contract. We will not tolerate any of our offspring living in shelters or rescues. If litter owner is unable to rescue offspring, Ohana Great Danes of Michigan must be notified and will care for this offspring at our own expense until said Dane can be placed in a proper home or stay here with us for the duration of said Dane's lifetime.
- 8) The average number of show/breeding quality offspring in any litter is very low. It is suggested to you that the companion offspring should be sold on a limited registration with a spay/neuter agreement. Any offspring sold with full registration should be a fine specimen of the breed in conformation, health, and temperament the offspring MUST BE approved by Ohana Great Danes of Michigan before sold as full registration. We limit the number of puppies sold on full registration with our approval to be 2. This is including if Bitch owner is keeping any back for their specific program. This is also including any offspring going in co-own or guardian home.

KEEP IN MIND THAT YOU AS THE LITTER OWNER, ARE ALSO REPRESENTING US BY SHARING OUR BLOODLINE, AND THAT WE WOULD DO THE SAME ABOVE AND BEYOND CARE AND RESPECT FOR YOU AS WELL.

Both parties stipulate that there are no other agreements other than those set forth in this document. Any legal action filed by either party in an effort to enforce this contract, will be filed in Oakland County, MICHIGAN. If any legal action occurs, OHANA GREAT DANES OF MICHIGAN will be entitled to recover reasonable costs and attorney's fees. Each party acknowledges that they have read and understand the terms and conditions of this Stud Service Contract and have voluntarily entered into and executed this agreement.
